Sub: Constitution of Committee for 'Children working in Teleserials/
Competitive Reality Shows/ Advertisements'.

The undersigned is directed say that for the purpose of safeguarding the rights of children working in Teleserials, Advertisements etc, it has been decided to set up a Committee under the National Commission for Protection of Child Rights (NCPCR).

- 2 The Composition of the Working Group is given in Annexure.
- 3 The terms of reference of the Committee are as under:
 - i) To carry out on the spot inspections of studios/ green room
 - ii) Formulate guidelines for working hours, working conditions, educational psychological and recreational needs
 - iii) To find out shortcomings in the existing laws/ regulations (if any) on the subject and recommend appropriate measures;
 - iv) Recommend any other measures that may be useful in addressing the concerns regarding the protection of child rights in Teleserials / Reality Shows/ Advertisements.
- 4 The Chairperson of the Committee, if deemed necessary, may constitute sub-groups and/ or may co-opt additional members.

5 The expenditure on TA/ DA etc of the official members in connection with the meetings of the Committee will be borne by the Parent Department/ Ministry/ Organisation, to which the member belongs. Non-official members will be entitled for TA/ DA as admissible as per SR 190 of TA Rules. The expenditure on TA/ DA to the Non-official member shall be borne by the NCPCR.
