

Position: Senior Consultant (Juvenile Justice)

(1) Nature of Work:

- i. To deal with all issues relating to Juvenile Justice in the Commission;
- ii. To handle all matters relating to the right to education of children with Juvenile Homes;
- iii. To assist the Expert/Working Group that may be constituted by NCPCR on the issues relating to Juvenile matters , including its meetings, minutes and correspondence.
- iv. Any other work that may be assigned from time to time.

(2) Qualifications/Experience:

- i. A postgraduate degree from a recognized University in social work/ psychology/ Child development/ sociology/ law/ Political science
- ii. 05 years of working experience in project formulation/ implementation/ monitoring/ scrutinizing/ analysing reports/ report writing in the Juvenile Justice sector;
- iii. Working knowledge in Computer, Fluency in English, knowledge of Hindi and regional language would be preferable.
- iv. Experience of dealing with the issues relating to Juvenile Justice or laws relating to J.J.Act would be an added advantage.
