#### **EXECUTIVE SUMMARY**

Substance abuse and drug addiction have emerged as one of the most pressing social issues amongst children and younger generation today. It is increasingly evident that the abuse of drugs and substances has become alarmingly common among adolescents and teenagers. The consequences of such abuse can be profoundly detrimental, not only to their present but also their prospects in future as well.

Physically, substance abuse can wreak havoc onto young bodies that are still developing. It can impair growth, damage organs, and lead to chronic health problems. Emotionally, it can lead adolescents to vulnerabilities, as substance abuse can destabilize their mood regulation and contribute to mental health disorders such as depression and anxiety. Economically, the costs associated with addiction—from purchasing substances to medical treatments—are significant burdens on individuals and society.

Psychologically, the impacts of Substance abuse amongst children and adolescents are multifaceted. Substance abuse diminishes decision-making abilities, leading to risky behaviors that can jeopardize their safety and future opportunities. Moreover, addiction alters brain chemistry, potentially hindering cognitive development and impairing learning and memory functions critical for academic and professional success.

The cumulative effects of substance abuse extend beyond the individual to affect families, communities, and the broader society. Addressing this issue comprehensively requires concerted efforts from parents, educators, healthcare professionals, and policymakers. Prevention through education, early intervention through accessible healthcare services, and rehabilitation programs are essential components in mitigating the devastating impact of substance abuse on the younger generation.

By prioritizing awareness, support systems, and evidence-based interventions, society can empower young people to make informed choices and protect their physical, emotional, economic, and psychological well-being. Ultimately, combating substance abuse among adolescents is crucial not only for their immediate health but also for fostering a productive and resilient future generation.

On this alarming issue of selling of drugs and substances to children near schools and educational institutions, a meeting was called by Hon'ble Prime Minister of India with Narcotics Control Bureau (NCB) wherein Narcotics Control Bureau made a presentation on situation of drug abuse in the country. On directions of Hon'ble Prime Minister of India, a meeting by NCB was convened with NCPCR, concerned Ministries and other relevant stakeholder was conducted. As one of the key outcomes based on deliberations held in the said meeting, a "Joint Action Plan (JAP)" was formulated to wean away children from using drugs and substances in surrounding areas of schools and educational institutions.

Joint Action Plan (JAP) on Prevention of Drugs and Substance Abuse among children and illicit trafficking is a public policy document and it adopts a holistic approach to address the alarming issue of drugs and substance abuse in children in the country through convergent and time bound manner.

JAP is first of its kind comprehensive document which has provision of interdepartmental convergence wherein all the stakeholders, agencies, duty bearers, authorities, media and parents and even children are required to perform their designated roles indicated in the document. This Joint Action Plan was released in February 2021 and in first phase it was rolled out in 272 vulnerable districts identified by Narcotics Control Bureau and Ministry of Social Justice and Empowerment, Government of India.

#### **OBJECTIVES of the Joint Action Plan -**

The core objective of the Joint Action Plan was to;

- Refrain children from using of harmful substances and drugs.
- Put an end on selling drugs and substances in the vicinity of schools and educational institutions.
- Ensure strict enforcement of the existing law and strengthening of enforcement of legal provisions.
- Highlight the roles and responsibilities of the stakeholders and strengthen their capacities to enhance the preventive measures.
- Ensure strict follow-ups and surveillance in various medical shops and pharmacies in the proximity of schools, other educational institutions, etc.
- Enhance awareness and sensitization amongst children, schools, pharmacists, etc. through workshops and seminars.

#### 1ST NATIONAL LEVEL REVIEW MEETING

After the roll-out of the Joint Action Plan, it was percolated to all the districts of the Country and a review of compliance and progress made by all the districts was conducted, virtually, by the Commission. In year 2022, first National level Review Meeting was conducted by NCPCR on roll out of Joint Action Plan in the 272 vulnerable districts. During the said Programme 20 Best Performing districts on roll out of Joint Action Plan were also felicitated.

# 2<sup>nd</sup> NATIONAL REVIEW MEETING ON IMPLEMENTATION OF JOINT ACTION PLAN

On the occasion of commemorating "International Day Against Drug Abuse and Illicit Trafficking", NCPCR with Narcotics Control Bureau had organized a National Consultation cum review meeting on implementation on Joint Action Plan (JAP) on "Prevention of Drugs and Substance Abuse among children & Illicit Trafficking" on June 30, 2024 at Vigyan Bhawan, New Delhi.

The main objective of the consultation was to review the status of implementation of Joint Action Plan in States/UTs. This was the second national level review meeting which conducted in accordance to the first review meeting of JAP conducted for 272 vulnerable districts identified by MoSJ&E. The event served as a platform to assess the progress of Joint Action Plan and to strategize further measures aimed at safeguarding children from the detrimental effects of substance abuse and preventing the spread of illicit drugs.

Furthermore, the Deputy Director General highlighted the pivotal roles and responsibilities of the Narcotics Control Bureau in addressing this significant social issue. He elaborated on the Bureau's strategies and approaches to combat drug and substance abuse, emphasizing their comprehensive efforts.

Moreover, he underscored the importance of the Joint Action Plan and various governmental schemes in tackling these challenges. He discussed the legal provisions and enforcement measures aimed at providing a holistic approach to curbing drug abuse.

The Deputy Director General (DDG,NCB) further emphasized upon the preventive measures outlined in the Joint Action Plan. He highlighted initiatives undertaken by different states and their respective districts, such as organizing marathons and runs against drug abuse, observing Nashamukt Pakhwada (Drug-Free Fortnight), and conducting awareness and sensitization events. These efforts also encompassed conferences, workshops involving schools, teachers, parents, and children.

In summary, the address provided a detailed perspective on the Narcotics Control Bureau's proactive stance against drug and substance abuse, emphasizing collaborative efforts, preventive measures, and community engagement initiatives across various levels of society.

Overall, the address underscored the commitment and coordinated efforts of NCPCR and NCB to tackle the complex and critical issue of drug abuse among children and adolescents and youth, aiming for effective solutions and positive outcomes.



#### Address by Shri Priyank Kanoongo, Chairperson, NCPCR



Shri Priyank Kanoongo, Chairperson of NCPCR, commenced his address by emphasizing the critical role of awareness and sensitization among children, parents, teachers, and the broader community in combating issues of substance abuse that threaten the innocence of children. He underscored the imperative to protect children, who are the bedrock of our nation, stating that the new motto of NCPCR, 'भविष्यो रक्षति रिक्ति:' urges us to safeguard our future by ensuring their well-being.

The Chairperson elaborated on significant provisions within the Joint Action Plan aimed at preventing the sale of psychotropic substances to children. He reviewed past initiatives undertaken since 2021-2022, which included- the installation of surveillance cameras (CCTVs) in chemist, medical, and pharmacist shops selling schedule H and X medicines, particularly, those in close proximity to school areas. These measures were reinforced by maintaining records of medical and drug shops around schools.

Moreover, Child Welfare Police Officers were entrusted with the responsibility of monitoring and ensuring the proper functioning of CCTVs in these areas. This involved regular checks, data analysis, and follow-ups across districts on a large scale.

In essence, **Shri Priyank Kanoongo's** address highlighted NCPCR's proactive approach in safeguarding children from substance abuse through comprehensive strategies, emphasizing awareness, surveillance, and collaborative efforts across various stakeholders. The initiatives underscored the commitment to creating a protective environment conducive to the growth and safety of our nation's youth.



The Chairperson, NCPCR underscored a crucial aspect regarding the utilization of existing governmental laws and schemes effectively, rather than proliferating new provisions that may duplicate existing ones. He emphasized the potential of these pre-existing laws in addressing societal challenges, provided they are refined and updated to suit current needs.

**Highlighting Section 133 of the Criminal Procedure Code (CrPC)**, which deals with conditional orders for the removal of nuisances, the Chairperson explained its relevance within the Joint Action Plan. This legal provision enables authorities to issue orders to remove nuisances that endanger public health or safety, thereby contributing to the prevention of drug and substance abuse among children.

By leveraging such legal frameworks, Chairperson, NCPCR emphasized the need for strategic implementation and enhancement of existing mechanisms. This approach ensures a more streamlined and effective response to combating social issues like substance abuse, reinforcing the importance of synergy between law enforcement, policy makers, and community stakeholders.

**Approximately 3 lakh** actions have been initiated against shop owners who have established their shops near educational institutes and schools. This proactive measure aims to prevent easy access to drugs and substances for students, thereby safeguarding their well-being and educational environment.

Additionally, **around 26,000** children in street situations have been identified as vulnerable to drug and substance abuse. Efforts are underway to address their needs and provide necessary support systems to prevent further exploitation and harm.

These statistics underscore the scale of the challenge posed by drug abuse among youth and highlight the concerted efforts being undertaken to protect vulnerable children and create safer environments around educational institutions. The actions taken reflect a commitment to enforcement, monitoring, and intervention strategies under the broader framework of the Joint Action Plan.

Several strategic initiatives were proposed by the Chairperson, NCPCR to strengthen efforts in safeguarding children from drug and substance abuse viz.:

- 1. Exclusive mobile internet connections for Children: Implementing dedicated mobile internet connections tailored for children ensures they access child-friendly content and are shielded from exposure to graphic or inappropriate materials. This measure aims to enhance digital safety and mitigate risks associated with unrestricted internet access.
- **2**. **Digital availability of data from medical stores**: Establishing digital platforms to access comprehensive information about medicines, including substances categorized under Schedule H and Schedule X drugs. This initiative promotes transparency and accountability in pharmaceutical transactions, helping to curb illegal sales and misuse.
- **3. Collaboration with NCERT and SCERT:** Partnering with the National Council of Educational Research and Training (NCERT) and State Council of Educational Research and Training (SCERT) to integrate

drug awareness and prevention modules into school curriculum. This collaboration ensures that educational institutions play a pivotal role in fostering awareness among students, teachers, and parents through structured programs aligned with the Joint Action Plans.

These proposed initiatives aim to create a holistic approach involving technology, education, and collaboration with educational bodies to effectively combat drug and substance abuse among children. By leveraging digital solutions, enhancing regulatory measures, and integrating prevention strategies into education frameworks, the goal is to create safer environments and empower young individuals with knowledge and resilience against substance abuse.

In summary, Shri Priyank Kanoongo's address advocated for a pragmatic approach in harnessing the potential of existing laws and schemes, such as Section 133 of CrPC, to bolster efforts under the Joint Action Plan. This strategic utilization aims to create a safer environment for children and uphold their well-being as a cornerstone of national development.

#### KEY NOTE ADDRESS BY-HON'BLE MINISTER OF STATE, MINISTRY OF HOME AFFAIRS -SHRI NITYANAND RAI



**Shri Nityanand Rai**, hon'ble Minister of State, Ministry of Home Affairs in his keynote address, emphasized upon the pressing need to combat drug abuse, particularly highlighting its devastating impact on children and future generation of the nation. He stressed upon the importance of engaging youth in positive and productive activities as alternatives to prevent them from falling into the trap of drug and substance abuse.

**Hon'ble Minister** highlighted that, the Government of India under the leadership of Hon'ble Prime Minister; Shri Narendra Modi has adopted a policy of '**Zero Tolerance**' against drugs to make a drug- free India. He further shared that Hon'ble Union Home Minister, has given passed strict orders to act against vendors and medical shops involved in the illegal sale of

any such substances. He reiterated that drugs are the enemy of the country's security and future, under the guidance of Hon'ble Prime Minister and Union Home Minister, the Ministry of Home Affairs is fully committed to eliminate this menace of drugs and substance abuse completely.

He underscored the importance of identifying and dismantling the networks and sources behind drug trafficking and peddling. He called for concerted efforts to trace the links between drug traffickers and their supply chains, as eradicating these connections is critical to effectively reducing the availability of drugs in the country. This firm stance underscores the government's recognition of drug abuse as a pressing national issue with far-reaching consequences for individuals, families, and society.

Hon'ble Minister in his address highlighted the behavioural changes in children and youth resulting from drug abuse, emphasizing the devastating effects it has on their physical, emotional, and psychological well-being. Drug addiction among the younger population not only disrupts their education and personal development but also poses a threat to the country's social fabric and economic progress. He underscored that the long-term societal harm caused by drug abuse requires urgent attention and a multifaceted approach to prevention, enforcement, and rehabilitation.

One of the critical aspects pointed by the Hon'ble Minister was the importance of identifying and dismantling drug trafficking networks and their sources. These networks, which often operate through intricate supply chains and sophisticated channels, are the backbone of the drug trade. The Minister stressed that tracing these links is vital to reducing the availability of drugs across the country. Such efforts require a combination of robust intelligence gathering, inter-agency coordination, and advanced technological tools to effectively disrupt the operations of drug traffickers.

The Minister also highlighted the increasing use of digital platforms by traffickers to evade law enforcement. This trend necessitates the adoption of advanced countermeasures, including cyber-surveillance; block chain analysis, and collaboration with international agencies. By focusing on the entire supply chain, from production to distribution, the government aims to dismantle the infrastructure supporting drug trafficking and cut off access to these substances at their source.

Hon'ble Minister shared that, the Ministry of Home Affairs has undertaken several key initiatives to combat drug abuse, with a strong focus on enforcement, coordination, and awareness. The **Narco Coordination** 

**Centre (NCORD)** serves as a vital platform for facilitating collaboration among various stakeholders, including law enforcement agencies, health departments, and state governments. NCORD's primary objective is to streamline operations, share intelligence, and ensure a unified response to drug-related challenges.

Further he mentioned that another significant initiative of the Ministry is the establishment of the **Anti-Narcotics Task Force (ANTF)**. This specialized task force is equipped to handle the complexities of drug trafficking operations, employing cutting-edge technologies and data-driven strategies. The ANTF works closely with intelligence agencies and local law enforcement to identify and neutralize drug trafficking networks, ensuring that offenders are apprehended and prosecuted as per the law.

In addition to these measures, the government has implemented stringent regulations and policies to curb the misuse of intoxicating drugs and substances. Regular inspections of medical shops, pharmacies, and manufacturing units are conducted to ensure compliance with legal standards. In case, vendors found engaging in the illegal sale of drugs, than they face severe penalties, including license cancellation and criminal prosecution.

While enforcement plays a critical role, the Hon'ble Minister also emphasized on the importance of community involvement in combating drug abuse. Public awareness campaigns are being intensified to educate people, particularly vulnerable groups such as adolescents and youth, about the ill effects of drugs and substance use. These campaigns leverage multiple platforms, including social media, schools, and community centres, to reach a wider audience.

He further recommended that Educational institutions should be encouraged to include drug awareness programs in their curriculum, fostering early intervention and prevention. The involvement of parents, teachers, and community leaders is crucial in identifying at-risk individuals and guiding them towards healthier choices. Furthermore, initiatives such as counselling services, help lines and rehabilitation programs are being strengthened to support individuals struggling with addiction and their families.

The fight against drug abuse is increasingly leveraging technology to enhance enforcement and prevention efforts. Real-time data analytics, geospatial mapping, and surveillance tools are being employed to monitor drug trafficking activities and predict emerging trends. These technologies enable law enforcement agencies to respond swiftly to threats and allocate resources more effectively.

The government is also collaborating with technology firms and research institutions to develop innovative solutions for detecting and intercepting drug consignments. For example, the use of AI-powered scanners and drones for monitoring border areas has proven effective in preventing the smuggling of drugs into the country.

Recognizing the transnational nature of drug trafficking, the government is actively engaging with international organizations and neighbouring countries to address the issue. Agreements on intelligence sharing, joint operations, and capacity-building initiatives have been established to strengthen collective efforts against drug trafficking. These collaborations ensure that traffickers operating across borders are apprehended and prosecuted, thereby disrupting the global drug trade.



The Hon'ble Minister emphasized that combating drug abuse requires a holistic approach that addresses both supply and demand. While enforcement measures aim to reduce the availability of drugs, equal attention is being given to addressing the underlying factors contributing to addiction. These include unemployment, poverty, lack of education, and mental health issues.

The government is promoting skill development programs, employment opportunities, and mental health initiatives to empower individuals and prevent them from falling into the cycle of addiction. Rehabilitation and reintegration programs are also being prioritized to help recovering addicts rebuild their lives and contribute positively to society.

Hon'ble Minister reiterated the strong stance of the Hon'ble Prime Minister on this critical issue. The Prime Minister's vision for a drug-free India is rooted in the belief that addressing the drug menace is essential for achieving the country's developmental goals. He has emphasized the need for a collective effort, where every citizen, organization, and institution plays a role in creating a healthier and more resilient society.

In conclusion, the Hon'ble Minister's address reflected a comprehensive and determined approach to combating drug abuse in India. By combining stringent enforcement measures with community participation, technological innovation, and international collaboration, the government aims to address the issue at its roots. The initiatives undertaken by the Ministry of Home Affairs, such as NCORD and ANTF, are critical components of this strategy, ensuring that the fight against drug abuse remains focused and effective.

#### LAUNCH OF "PRAHARI PORTAL"



"Prahari Portal" was launched by Hon'ble Minister of State, Ministry of Home Affairs -**Shri. Nityanand Rai** during the programme.

Joint Action Plan has given a provision of constitution of "Prahari Clubs" in schools. The main objective of the Prahari Clubs is to ensure that the drugs and substances in surrounding areas selling of schools/educational institutions is prohibited and to sensitize students to be more vigilant about any activity of drugs and substance abuse in the schools/educational institutions. "Prahari Clubs" are the convergence of these existing clubs in schools like- Eco clubs, Cultural Clubs, Red Ribbon Clubs and others. "Prahari Clubs" provides a platform for the students to come together, meet, discuss and plan activities for their own development as well as that of the society to curb the menace of drugs and substance abuse in and near schools.

Each Prahari Club should have 20-25 students in total selected from class 6 to class 12. Students of these Clubs shall undertake random checks to ascertain that no illicit or other harmful substances are being given to children. Members of the Prahari Club shall any such confidential information with Prahari teacher in charge of the club, who will be nominated by the school for coordination and mentor the club.

#### "Prahari Portal"-

To streamline the functioning of the "Prahari Clubs" in schools/educational institutions, NCPCR has developed and designed a "**Prahari Portal**" to maintain information on constitution and functioning of "Prahari Clubs".

Prahari Portal is a MIS that will capture the school wise data of functioning of the Prahari Clubs in the district. In this regard, NCPCR shall be providing the link to the districts/schools for registration on Prahari Portal. After getting the details on the constitution of Prahari Clubs in the schools consisting of students and teacher, quarterly activities shall be planned by the Prahari Clubs in consultation with NCPCR. These activities shall be conducted by the students of the

Prahari Clubs in the schools. The report of the activities undertaken by these Clubs shall be updated on the Prahari Portal on quarterly basis.

Through this Prahari Portal any case of using children for drugs and substances or giving any intoxicating substances to children shall be reported to the Police for registration of FIR under section 77 and 78 of the Juvenile Justice (Care & Protection of Children) Act, 2015.

#### **SESSION-1**

ROLE OF UNODC IN "PREVENTION OF DRUGS AND SUBSTANCE ABUSE AND ILLICIT TRAFFICKING"-MR.MARCO TEIXEIRA, REGIONAL REPRESENTATIVE, UNODC, SOUTH ASIA-



Mr. Marco Teixeria, Regional Representative of UNODC, highlighted several crucial points during his address, emphasizing on the urgent need for collective action to combat drug abuse, especially among children and youth. He began by appreciating the efforts by the National Commission for Protection of Child Rights (NCPCR) and thanking Shri Priyank Kanoongo, Chairperson, NCPCR for inviting him to this forum.

He stated that the increasing prevalence of drug abuse among young adults is a pressing concern. Recent trends highlight the ease of access to synthetic drugs and the role of online platforms in enabling children to obtain these substances. This alarming development threatens their health, safety, and future. Addressing these issues requires a collective approach involving all stakeholders.

He further underlined the role of UNODC in combating Drug and Substance Abuse and it's illicit trafficking. He stated that, at UNODC, they are committed to providing technical support to National and International entities in combating drug abuse. Central to the efforts is promoting **life skills programs** that equip children with tools to make informed decisions and avoid harmful influences. Building strong, trusting relationships with children is equally vital, fostering environments where they feel understood and supported.

Mr Marco also highlighted that use of **evidence-based parenting skills programs** that may empower caregivers to connect with children in meaningful ways. He pointed out that it is very important to "reach the children the way they want to be reached". These initiatives can prevent the first exposure to substances and nurture integrity and healthy behaviours.

At last he mentioned about the **Champion** initiative of UNODC that aims to enhance children's resilience, creating the right skills and environments for their development. In the end, he reiterated the need for collaboration and to create the right set of **skills**, **and environment** that our children need to thrive. By expanding our approaches and leveraging existing tools, we can ensure that our initiatives yield the best possible outcomes, aligning with our shared goals and policies.


# PRESENTATIONS BY STATES/UTs ON THE IMPLEMENTATION OF THE JOINT ACTION PLAN

#### **CONCLUDING SESSION AND WAY FORWARD**

**NCPCR** Chairperson, Shri. Priyank Kanoongo, underscored and directed the states/UTs to take stringent actions in their respective states. Some of the recommendations are as follows:

1. In reference to Punjab: The Chairperson while addressing the query of the concerned authority emphasised on the intricacy of the application of section 133 of the Criminal Procedure Code (CrPC) and emphasized the authority of District Magistrate in giving order to CWPO to do periodical monitoring under this section itself. Further, while addressing Tamil Nadu, he acknowledged that NCPCR will be the nodal authority in case of assistance and principal secretary will be

in charge for all the initiatives taken.



- 2. In reference to Meghalaya: The Chairperson directed the state to increase monitoring by CWPO because of the increased HIV cases in north east due to several repetitive instances of using only a single syringe in several hospitals which is dangerous. It has been directed to the NCPCR to expediate the implementation of registration of every IRCA de addiction centre as the law requires.
- 3. In reference to Telangana and Andhra Pradesh: The Chairperson directed the state to create Prahari club as soon as possible so as to continue with the uniformity which has been created under the Prahari portal and not let the state lag behind. Moreover, to direct principal secretary education to give order to districts to create these clubs even if there exist several other clubs with similar purposes.

Moreover, the chairperson pointed out that in both these states children are being used by weed suppliers and then charged under NDPS Act and other laws whereby they are then placed in observation homes. However, it is suggested that instead they should be treated as CNCP under section 78 and an Individual Care Plan (ICP) should be formulated till the age of 21 after which the child should be sent to children's home and not observation house as they themselves are vulnerable. Further, it was directed that Telangana state should find data of children charged under NDPS act or other relevant law and they be treated as CNCP.

To ensure effective implementation, recommendations emphasized practicality and a vision to create a better framework to address the drug abuse amongst children which are as follows:

- The Chairperson stated the importance on relying on section 78 of Juvenile Justice Act 2015 and properly applies it to rescue children who are being used by peddlers to sell their drugs, and further appropriately put these children under CNCP and provide rehabilitation after Juvenile Justice Board's decision.
- The Chairperson emphasized on taking stricter approach with social media platforms, e-commerce, online means and creating stricter regulations in relation to their violations in interest of children. The commission highlighted the proactive approach taken by NCPCR commission in daily sending out notices to these companies as well as creating required facilities to target the online posts which promote or sell drugs and their sources and thereby, urged other commissions to share their concerns with them in case of unavailability of resources.
- The Chairperson articulated an important recommendation which the Commission had proposed earlier as well. This recommendation related to their persevering endeavor at digitalizing the pharmacy shops schedule acts and other relevant laws and creating a uniform data base to ensure a more uniform and concise work load to help make it easy to reach and rescue children. The chairperson urged all state commissions to convince the state governments to go ahead with this desired and much needed recommendation.
- Lastly, he emphasized on the establishment of Prahari clubs and portal and establishment of one club in each school. On addressing a query, he emphasized on bringing about one activity which will involve parents, community, PTA and school. He also addressed on solidifying the ideas

discussed already in past meeting regarding alcohol shops and uniform policy.

The National Level Review and Consultation on the Implementation of the Joint Action Plan for Preventing Drug and Substance Abuse Among Children and Combating Illicit Trafficking serves as a critical platform for evaluating the effectiveness of strategies and interventions over the past two years. This meeting is essential not only for assessing the progress made but also for identifying areas requiring further attention.

The comparison of data from two consecutive years provides valuable insights into trends, successes, and persistent challenges in the fight against drug abuse and trafficking, particularly among vulnerable populations like children. However, the challenges that persist cannot be overlooked. The regional disparities in drug usage, particularly in border areas and the northeast, highlight the need for more targeted and culturally sensitive interventions. Additionally, while law enforcement has made strides in combating trafficking, the evolving nature of trafficking networks requires continuous adaptation and innovation in strategies.

Access to rehabilitation services also remains a critical issue, with many children still unable to receive the help they need due to logistical, social, and economic barriers. The National Level Review and Consultation on the Implementation of the Joint Action Plan has provided invaluable insights into the progress made over the past two years and the challenges that remain. While significant strides have been made in preventing drug abuse among children and combating illicit trafficking, the data highlights the need for continued vigilance, innovation, and collaboration.

The Joint Action Plan has led to notable progress in several key areas aimed at preventing drug and substance abuse among children and combating illicit trafficking. A significant achievement is the widespread establishment of Prahari Clubs, which engage youth in schools and communities as active participants in promoting awareness and reporting suspicious activities related to substance abuse. These clubs foster a drug-free culture and empower young people to play a proactive role in safeguarding their peers.

Additionally, there has been a marked increase in the number of cases registered u/s (6) of Cigarettes and Other Tobacco Products (Prohibition

of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act, 2003 (COTPA, 2003), indicating stronger enforcement efforts to curb the sale of tobacco products to minors. This rise in enforcement highlights the commitment of law enforcement agencies to protect children from tobacco-related harm.

Furthermore, the installation of surveillance cameras in medical shops has enhanced monitoring of drug sales, particularly in preventing the illegal sale of prescription drugs to minors. This initiative has improved compliance with regulations, ensuring a safer environment for children by deterring illicit activities. These developments reflect a concerted effort to create a safer, more protective environment for children across the country.

By addressing the identified gaps and building on the successes achieved, we can move closer to our goal of creating a safer, healthier future for all children. While challenges remain, the continued efforts to strengthen coordination, enhance capacity, and ensure sustained funding will be crucial to the success of the JAP. By fostering a collaborative approach that brings together government, civil society, and community stakeholders, the Commission aims to build a future where every child in India can grow up free from fear, harm, and exploitation, fully realizing their potential.
