Agenda Item No.8 Cortorehensive Report on Initiatives of NCI CR for Welfare, Safety, and securit of Children during place and part of the Juvenile Justice Act, 2015, and in response to the escalating challenges faced by children during the COVID-19 pandemic, the Commission developed an online tracking portal, "Bal Swaraj (COVID-Care link)," for children in need of care and protection. This portal was also extended to track children who lost either one or both parents during the COVID-19 crisis.

Pursuant to the Hon'ble Supreme Court's order dated 28.05.2021 in SMWP No. 4 of 2020, "In Re: Contagion of COVID-19 Virus in Children Homes," all district authorities across States/Union Territories were directed to input data regarding orphaned children into the Commission's portal.

The Commission has undertaken various significant initiatives to ensure the welfare, safety, and security of children during both the pre- and post-pandemic periods. Accordingly, the Commission has prepared a Comprehensive Report to document its efforts for the protection of children in need of care and protection across the country.

Decision: This Report was placed before the Commission for its information and approval. This was noted and approved in principle by the Commission.

Agenda item No.5. Programmatic Activities to be interacted North Fast Cell in the FY 2024.

In this regard it may kindly be noted that in the Financial Year 2024-25, the NE Cell has completed seven (7) activities so far. Additionally Forty One (41) individual program activities are in process in eight (8) States of North Eastern Region including Sikkim.

It may also be noted that the Commission had published 40 individual program activities to be completed in NER through GeM in the month of August 2024, which are in process now. However, in case of any further activities required to be undertaken by the Commission in NER based on the availability of funds in NE Cell, the same shall be undertaken directly with the concerned SCPCRs and/or may be published on GeM based on the directions of the Commission.
